

Recommended number of lamps per 600 watt dimmer²

While an LED lamp may draw as few as 10 watts continuously, it could have an in-rush current spike (maximum, instantaneous input) which may limit the number of lamps you can install on one dimmer. The following table provides a recommended maximum quantity of LS lamps that should be used on a typical approved 600W dimmer.

Ex: Max number of A19 60W lamps, with an 80W in-rush, that can be used on 600W dimmer = 7 $\,$
